

WEBSITE TERMS & CONDITIONS

Thank you for visiting this website. Please read these terms and conditions (“Terms”) carefully before browsing this website or making a donation.

These Terms set out the terms and conditions that will apply to the use of the website www.reforestation.org.uk (the “Website”) and to any donation made through the Website.

By confirming that you have read and accepted these Terms when you submit your donation through the Website, you confirm your unconditional acceptance thereto. If you do not accept these Terms please do not use this Website.

Reforestation Ltd a company incorporated under the laws of England, with registered address located at 1 West Street, Lewes, BN7 2NZ (“Reforestation”); reference to “we” or “us” is intended to Reforestation. “Customer” or “you” means the user of this Website.

These Terms with the Donation Confirmation (as defined below) constitute the Contract between Reforestation and you for the conclusion of the Donation (as defined below). No other terms and conditions shall apply.

A copy of these Terms can be stored electronically or printed by the Customer.

1. Using the Website

1.1. You agree to only use the Website in a manner that complies with all applicable laws and regulations, it is consistent with this Terms and does not infringe the rights of anyone else, nor restrict or inhibit their use and enjoyment of the Website.

2. Registration

2.1. If you want to make use of certain features of our Websites or to carry out certain actions (such taking action and participate in what we do) you must first register with us in order to create your personal account. During the registration process, you will be asked to provide some information about you and to create a user name and a password, which you will need to use each time you enter into your personal account.

2.2. You must ensure that you keep your username and password confidential and that you do not disclose them to anyone. You should also restrict access to your computer to prevent unauthorised access to your account. You will be responsible for all activities which occur under your username and password. It is your responsibility to immediately notify us of any unauthorised use of your username and password or any other breach of security as soon as you become aware of it.

3. Donations

3.1. Users can donate money to support our activities, by completing donations online (“Donation”). Only registered Customers can place Donations. To do so, users shall access the Donations section on our Website and contribute to our activities and goals.

3.2. To submit Donations, users are required to provide their name and contact details, to indicate the amount of the Donation, to select the available currency and to insert the details of the preferred method of payment. The Website allows to receive donations via Paypal and credit/debit cards.

3.3. Before submitting the Donation and in order to complete the same, Customer will be required to accept these Terms by ticking the relevant box at the end of the confirmation page.

3.4. After a Donation has been submitted, we will send the Customer an email, at the email address provided by Customer at the time of registration on the Website, confirming that the Donation has been correctly received and it is being processed (“Donation Confirmation”). When you receive the Donation Confirmation, you are no longer able to withdraw your Donation.

3.5. Within 5 days from your Donation, we will send all necessary fiscal documentation related to your Donation via email, at the email address submitted at the time of registration on the Website. In addition, all your Donations will remain visible on the Donation section of your account.

4. Privacy

4.1 We take your privacy very seriously and we will process all of your personal information in accordance with all applicable data protection laws. Please read our Privacy Policy for additional information.

5. Intellectual Property Rights

5.1.
